RE: FINANCIAL ADVISORY SERVICES

General Obligation Temporary Notes, Series A 2020, for municipal gas utility project

Stifel, Nicolaus & Company, Incorporated ("Stifel") presents for your acceptance this agreement to retain Stifel as financial advisor to the City of Neodesha, Kansas ("Issuer") for the proposed General Obligation Temporary Notes, Series A 2020 (the "Notes") estimated to be issued in the aggregate principal amount of approximately \$1,766,000. This agreement will be effective on the date signed by an authorized representative of Issuer and will authorize Stifel to act as financial advisor through the completed sale of the proposed Notes, at which time this agreement will terminate. This agreement may also be terminated on thirty (30) days written notice by either party.

- 1. <u>Scope of Work.</u> Stifel agrees to perform the following services for Issuer with respect to the Notes:
 - a. Assume overall responsibility for the financial analysis and structuring recommendations for the Notes;
 - In a private placement transaction, assist the Issuer, as requested, with the development of the Request for Proposal/Terms Sheet and related package which would be distributed by the Issuer (after due diligence) to designated financial institution(s);
 - Assist Issuer, as requested, in the selection of a purchaser(s), including review of purchaser(s) recommendations to the extent requested in writing by Issuer, and coordinate all activities of the purchaser(s);
 - d. Coordinate with consultants, accountants, bond counsel, other attorneys and staff in connection with the sale of the Notes;
 - e. Coordinate financing time schedule, distribution of documents, wire-transfer of funds, delivery of notes and note closing;
 - f. Attend Issuer meetings as requested, with reasonable advance notice;
 - g. Provide such other services as are mutually agreed upon in writing by Issuer and Stifel.
- 2. <u>Issuer's Obligations</u>. Issuer agrees that, with respect to the Notes, its staff and consultants will cooperate with Stifel and make available any data in the possession of

Issuer necessary to perform Stifel's financial advisory services and regulatory obligations as described in Exhibit A to this agreement.

3. Regulatory Disclosures:

- a. Issuer is aware of Section 975 of the Dodd-Frank Wall Street Reform and Consumer Protection Act and the Securities and Exchange Commission's adopted rule commonly known as the "Municipal Advisor Rule" (SEC Rule 15Ba1-1 to 15Ba1-8 -"the Rule"). Stifel will be serving as a municipal advisor to the Issuer under the Rule and this agreement documents the municipal advisory relationship between Stifel and the Issuer.
- b. MSRB Rule G-42 requires that a municipal advisor provide its client with certain written disclosures. Please see Exhibit A to this agreement for those disclosures.

4. Compensation:

MSRB Rule G-42 Disclosures

As municipal advisor to the City of Neodesha, Kansas ("you"), Stifel Nicolaus ("Stifel" or "we") is subject to the rules of the Municipal Securities Rulemaking Board (MSRB), including MSRB Rule G-42. The rule directs us to make certain disclosures to you. Please review the following disclosures and contact your Stifel municipal advisor if you have any questions.

Our Duties as Your Municipal Advisor

Rule G-42 describes our basic duties to you. Most importantly, we owe you a fiduciary duty, the principal element of which is a duty of loyalty. Under the duty of loyalty, we are required to deal honestly and in the utmost good faith with you and to act in your best interests without regard to our financial or other interests. We may not serve as your municipal advisor if we believe that we have any conflicts of interest that we cannot manage or mitigate so that we can act in your best interests.

Rule G-42 also provides that we owe you a duty of care. As part of that duty, we must possess the degree of knowledge and expertise needed to provide you with informed advice. Also, under that duty, when we make recommendations to you or help you to evaluate the recommendations of others, we may need to ask questions to make sure that we have all the relevant facts.

Disclosure of Conflicts

Rule G-42 requires us to disclose to you any known material, actual or potential conflicts of interest that could reasonably be expected to impair our ability to provide you with advice, including any conflicts associated with contingent fee arrangements. As described in our engagement letter, the payment of our fee will be contingent on the closing of the note issue described in the engagement letter and the amount of compensation will be based on a percentage of the principal amount of the note issue. While this form of compensation is customary in the municipal securities market, it presents a conflict of interest since we may have an incentive to recommend a transaction to you that is unnecessary or to recommend that the size of the note issue be larger than is necessary. We would, of course, be willing to discuss an alternative fee arrangement, if that is your preference.

Stifel has not identified any additional potential or actual material conflicts that require disclosure.

Legal and Disciplinary Event Disclosures

Each firm that is registered as a municipal advisor with the U.S. Securities and Exchange Commission (SEC) is required to file Form MA with the SEC and update that form periodically and as events change. The firm is also required to file a Form MA-I for each of its employees who is engaged in municipal advisory activities. Item 6 of each Form MA-I requires comparable disclosure about a municipal advisor individual, as well as customer complaint, arbitration, investigation, termination, financial, and judgment/lien disclosure. When an individual has a disciplinary history, Form MA-1 permits us to cross-reference to that individual's Form U-4. Our Form MA was amended on July 14, 2017 to reflect the following settlement with FINRA:

In June 2017, Stifel agreed to pay a fine of \$125,000 to settle an alleged violation of MSRB Rule G-23. Stifel determined that a private placement with the county in which Stifel's school district client was located was a lower cost alternative for the school district than a public offering. Stifel presented the idea to the school district, which agreed to hire Stifel as its placement agent. Nevertheless, two months elapsed before Stifel provided disclosure to the school district that, in its role as placement agent, it was not a fiduciary to the school district as required by MSRB Rule G-23. The FINRA settlement document states that: "Because it failed to provide the role disclosure required by MSRB Rule G-23 in a timely manner, Stifel acted as both financial advisor and placement agent for the [school district] in connection with the [Bonds], in violation of MSRB Rule G-23." The alleged violation took place in 2012. Stifel now has robust procedures in place that are designed to result in timely G-23 disclosures to underwriting/placement clients.

We do not believe that any of the legal or disciplinary event disclosures described in our Form MA is material to our ability to serve as your municipal advisor.

Evaluation of Recommendations/Suitability

- financial capacity to withstand changes in market conditions during the term of the municipal financial product or the period that municipal securities to be issued in the municipal securities transaction were reasonably expected to be outstanding, and
- any other material information known by the municipal advisor about the client and the municipal securities transaction or municipal financial product, after reasonable inquiry.

LEASE BETWEEN CITY OF NEODESHA AND WILSON MEDICAL CENTER

Agreement between the City of Neodesha, 1407 N. 8th, Neodesha, Kansas 66757 ("Landlord"), and the Wilson Medical Center, 2600 Ottawa Road, Neodesha, Kansas 66757 ("Tenant"), made February 24, 2020.

- 1. AGREEMENT TO LEASE. Landlord agrees to lease to Tenant, and Tenant agrees to lease from Landlord, the premises on the terms and conditions stated in this Lease.
- **2. PREMISES**. The premises leased is the building located at 604 West Main Street, Neodesha, Kansas 66757 ("the Premises").
- **3. TERM**. The term of this Lease begins on March 1, 2020, and ends December 31, 2020 ("the Term"). This term must be approved for renewal on an annual basis.
- **4. RENT**. Tenant will pay Landlord, without demand, a total monthly rent of \$750.00. Such rent is payable monthly by the 15th day of each month at Landlord's address stated above (or at such other address as Landlord may require).
- 5. GET FIT. Wilson Medical Center agrees to become a partner with the City of Neodesha by providing the City employees and their families the same rates provided to Wilson Medical Center employees. (See Exhibit A)
- **6. UTILITIES**. Tenant is responsible for making arrangements for, and paying when billed, all utility and other services for the Premises, including electricity, gas, sewer, water, storm water and solid waste.
- 7. REPAIRS. Tenant must keep the Premises, including the grounds and all appliances, equipment, furniture, furnishings, and other personal property clean and in good order. Repairs on structure, other than normal wear and tear, shall be the responsibility of the Landlord. Tenant shall notify Landlord if any repairs are needed, and Landlord shall effect repairs in a reasonable period of time, given other City priorities. Any damage caused by tenant or tenant's activities, shall be the responsibility of the tenant.
- **8. ALTERATIONS**. Tenant may not alter the Premises without the prior written consent of Landlord in each instance. All alterations made by Tenant will, unless Landlord requests removal, become Landlord's property and remain on the Premises at the termination of this Lease without any compensation to Tenant. If Landlord demands or permits removal, Tenant will put that part of the Premises into the same condition as existed prior to the alteration.

9. FIRE AND CASUALTY.

a. NOTICE. In the event of fire or other damage to the Premises, Tenant will immediately notify Landlord.

- b. PARTIAL DAMAGE AND CONDITIONS TO CONTINUED EFFECTIVENESS. If the Premises are only partially damaged and are unusable and Landlord makes full repairs within 14 days, this Lease will continue.
- c. CONDITIONS OF TERMINATION. If the Premises are rendered unusable, continued occupancy would be illegal, or Landlord cannot or does not repair within 14 days, Tenant may immediately vacate the Premises and notify Landlord in writing within 15 days after vacating of his intent to terminate, in which case this Lease will terminate as of the date of vacating.
- **10. LIABILITY**. Landlord is not liable for any loss, damage, or expense suffered by any person on or about the Premises, except that which is caused by Landlord's negligence. Tenant shall indemnify and hold Landlord harmless from any claims, losses or damages of every type or nature, including attorney fees and expenses, arising out of Tenant's use of the Premises.
- 11. ASSIGNMENT OR SUBLETTING. Tenant may not assign this Lease, sublet all or any part of the Premises, or allow any other person or entity to occupy the Premises.
- 12. INSURANCE REQUIREMENTS. Tenant agrees not to do anything that will increase the insurance premiums payable with respect to the Premises. Tenant shall make arrangements for Landlord to be an additional insured on the Tenant's general liability policy, with limits of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate. Annually, or at any other time requested by Landlord, Tenant shall provide a current ACORD certificate of liability insurance to Landlord reflecting Landlord as an additional insured. Tenant shall be responsible for its personal property on the Premises and maintain fire and casualty insurance on its personal property on the Premises.
- 13. RIGHT OF ENTRY. Landlord may enter the Premises at reasonable times in order to examine the Premises or make repairs or alterations. In the event of an actual or apparent emergency, Landlord may enter the Premises at any time without notice. Tenant will not change any lock or install additional locks without Landlord's prior written consent and without providing Landlord a copy of all keys.
- **14. NOTICES.** All notices under this Lease must be in writing and either delivered personally or mailed by certified mail to the address of Landlord and Tenant stated above (or at such other address as Landlord may designate by notice to Tenant). Notices that are sent by mail will be deemed delivered 2 days after they are mailed.

15. DEFAULT AND REMEDIES.

- a. NOTICE OF DEFAULT. Landlord agrees to provide 10 days' written notice to Tenant to correct any default under this Lease.
- b. TERMINATION OF LEASE. If Tenant fails to correct any default within such 10-day period, or if Tenant fails to pay rent or additional rent provided for in this Lease on it due date plus a grace period of 5 days, then Landlord may cancel this Lease by 30 days' prior written notice to Tenant. On the date stated in Landlord's notice, this Lease and Tenant's rights under this Lease will terminate, and Tenant must surrender the Premises. Tenant remains liable, after such termination, for rent, costs and damages provided in this Lease.

- c. OTHER REMEDIES. If this Lease is terminated because of Tenant's default, Landlord may, in addition to any other rights and remedies available to him, (1) enter the Premises and have Tenant and Tenant's property removed, and (2) use any dispossession, eviction, and similar legal proceedings available.
- **16. CURING TENANT'S DEFAULTS.** If Tenant does not correct a default after 10 days' notice by Landlord, Landlord may remedy such default on behalf of Tenant, and any costs incurred by Landlord will be payable by Tenant, as additional rent under this Lease.
- 17. SURRENDER. At the end of the Term or earlier termination of this Lease, Tenant will quit and surrender the Premises in as good order and condition as they were on the commencement date of this Lease, except for ordinary wear and tear and damage by the elements.
- **18. QUIET ENJOYMENT.** If Tenant is not in default under this Lease, Tenant may peaceably and quietly enjoy the Premises during the Term.
- 19. NO WAIVER. If Landlord fails to enforce any provision of this Lease, he is not deemed to waive such provision and is not prevented from enforcing such provision thereafter.
- **20. SEVERABILITY**. If any provision of this Lease is invalid or unenforceable, the balance of this Lease shall remain effective, absent any such provision.
- **21. SUCCESSORS.** This Lease is binding on all persons or entities that may succeed to the rights of Landlord or Tenant, including heirs, executors, successors, assigns and purchasers, as applicable.
- **22. MERGER**. This Lease represents the entire agreement between Landlord and Tenant. Landlord has made no representations other than what is contained in this Lease.
- **23. AMENDMENTS.** No change in this Lease shall be effective unless it is in writing and signed by both Landlord and Tenant.
- **24. RENEWAL OF LEASE AGREEMENT.** This lease agreement shall renew annually for a one-year term unless either the lessee or lessor notify the other party in writing 30 days prior to end of term that the lease should either be modified or terminated. In the case of such notification the parties shall make any modifications prior to renewing the lease or lease shall terminate on that date. This automatic renewal paragraph shall not affect either party's ability to terminate the lease for any other reason allowable under the terms of said lease.
- **25. POWERS OF LANDLORD'S AGENT.** All rights and remedies of Landlord under this Lease or at law may be exercised by Landlord or by Landlord's employees in its name.
